**IMPORTANT- NOTE CANCELLATION POLICY BELOW**

The cancellation policy is as follows: A show cancellation must be received in the show office IN WRITING. A cancellation within ONE WEEK of application deadline will receive a refund of all fees, less a \$50.00 cancellation fee. A cancellation after that will receive a refund of booth fee only, but no show fee. NO REFUND WILL BE GIVEN FOR CANCELLATIONS RECEIVED WITHIN ONE MONTH OF SHOW START DATE.

**IMPORTANT:** In consideration of the Show Contract and the mutual promises contained therein, the receipt and sufficiency of which is hereby acknowledged, Exhibitor agrees to defend, indemnify, and hold harmless GGAA/FMNC and Landlord against any and all claims, losses, costs, expenses, liabilities, suits, damages, diminutions in value and deficiencies, including without limitation, counsel fees and all amounts paid in settlement of any claim, action or suit ("Claims") which may be asserted against Exhibitor, GGAA/FMNC or Landlord, which arises out of or results from the Exhibitor's acts or omissions. In addition to the foregoing, Exhibitor also expressly waives for any of his employees, relatives, agents or invitees, any Claims which may be asserted against GGAA/FMNC or Landlord for the aforementioned Claims, including, but not limited to, injury or death of a person, loss of use, loss or damage to property, however occurring, which arise out of or are in any way connected with the use of the exhibition space, participation in, or attendance at, the Market to which this show Contract is an application. Exhibitor further agrees to defend, indemnify and hold harmless GGAA/FMNC against and from any Claims of any kind, including but not limited to any Claims asserted by the Landlord against GGAA/FMNC in any way arising out of or connected with the use or occupancy of the premises by the Exhibitor or his employees, relatives, agents or invitees, resulting from any cause whatsoever. Exhibitor hereby agrees to abide by the rules and regulations of the association, to be responsible for the conduct of all its personnel working in assigned space. GGAA/FMNC reserves the right to require proof of insurance from Exhibitor. This show Contract supersedes all oral statements and representations, and any prior, contemporaneous, or subsequent oral representations made by GGAA/FMNC, and Exhibitor acknowledges that any prior, contemporaneous, or subsequent oral representations made by GGAA/FMNC were not relied upon in entering into any contract. In the event that legal action or arbitration is commenced by either party to enforce this Agreement, the substantially prevailing party, in addition to any other remedy, shall be entitled to receive its reasonable attorney's fees and costs, including any such fees and costs reasonably expended before commencement or arbitration or litigation, and on appeal, and in collection of any judgment.
