Exhibitor further agrees to defend, indemnify and hold harmless GGAA/FMNC against and from any Claims of any kind, including but not limited to any Claims asserted by the Landlord against GGAA/FMNC in any way arising out of or connected with the use or occupancy of the premises by the Exhibitor or his employees, relatives, agents or invitees, resulting from any cause whatsoever. Exhibitor hereby agrees to abide by the rules and regulations of the association, to be responsible for the conduct of all its personnel working in assigned space. GGAA/FMNC reserves the right to require proof of insurance from Exhibitor. This show Contract supersedes all oral statements and representations, and any prior, contemporaneous, or subsequent oral representations made by GGAA/FMNC, and Exhibitor acknowledges that any prior, contemporaneous, or subsequent oral representations made by GGAA/FMNC were not relied upon in entering into any contract. In the event that legal action or arbitration is commenced by either party to enforce this Agreement, the substantially prevailing party, in addition to any other remedy, shall be entitled to receive its reasonable attorney's fees and costs, including any such fees and costs reasonably expended before commencement or arbitration or litigation, and on appeal, and in collection of any judgment.
