In the event that legal action or arbitration is commenced by either party to enforce this Agreement, the substantially prevailing party, in addition to any other remedy, shall be entitled to receive its reasonable attorney's fees and costs, including any such fees and costs reasonably expended before commencement or arbitration or litigation, and on appeal, and in collection of any judgment.
